**Riverstone Credit Management LLC** — \$100 million senior secured delayed-draw green loan facility with ESG-linked pricing to Harland & Wolff Group Holdings plc, a UK-based fabrication and maintenance company operating in the maritime, defence, oil & gas and renewable energy sectors, including in relation

to UK offshore wind projects

**Savannah Energy Plc** — financing arrangements in respect of Savannah's acquisition of Exxon and Petronas' entire interests in the Doba oil field in Chad and their shareholding in the Chad-Cameroon Pipeline and Floating, Storage and Offloading vessel for a total consideration of up to \$676 million
