*MB Minerals L.P. —* \$143.1 million sale of Midland Basin mineral and royalty interests to Kimbell Royalty Partners, LP

Driftwood Energy Operating, LLC - sale of assets in the Midland Basin to Vital Energy, Inc

Private oil and gas operator – \$130 million sale of non-operated interests in the Northern Delaware Basin

**Sable Offshore Corp.** — purchase from Exxon Mobil Corporation of the Santa Ynez field in Federal waters offshore California and associated onshore processing and pipeline assets, including pipeline assets acquired by Exxon Mobil from Plains Pipeline L.P. and the merger with Flame Acquisition Corp., a special purpose acquisition entity

*Titus Oil & Gas Production, LLC and Titus Oil & Gas Production II, LLC* — \$627 million divestiture of New Mexico assets located in the northern Delaware Basin owned by Titus Oil & Gas Production, LLC, Titus Oil & Gas Production II, LLC, and their affiliates to Earthstone Energy, Inc. (NYSE:ESTE). The aggregate purchase price consists of \$575 million in cash and approximately 3.9 million shares of Earthstone's Class A common stock valued at \$52 million based on a closing share price of \$13.51 on June 24, 2022.

**Bison Oil & Gas Partners II, LLC** – \$300 million total cash divestiture DJ Basin operator to Civitas Resources, Inc., which was restructured from stock and cash consideration prior to closing

*Apache Corporation* — \$805 million minerals divestiture of primarily non-operated properties across west Texas and southeast New Mexico in the Delaware Basin

*Sabalo Energy, LLC* — sale of Midland Basin assets to Laredo Petroleum Inc. for \$606 million in cash and 2.507 million shares of Laredo's common stock

**TC Energy Corporation** — approximately \$1.275 billion sale of US midstream assets held by its subsidiary, Columbia Midstream Group, to a subsidiary of UGI Corporation

*WaterBridge Resources LLC* — \$238 million acquisition of salt water disposal assets from NGL Energy Partners LP

*WaterBridge Resources LLC* — \$125 million acquisition of produced water assets from PDC Energy, Inc. and negotiation of water services agreements

**Sabalo Energy, LLC** – divestiture of produced water gathering and recycling infrastructure assets in the Midland Basin to H<sub>2</sub>O Midstream LLC, including negotiation of long-term produced water gathering, disposal and recycling agreements

*Independent oil and natural gas exploration and production company* – sale of substantially all of its Gulf of Mexico assets to Fieldwood Energy LLC for over \$700 million

*Three Rivers Operating Company III LLC* — sale of 59,000 net acres in the Delaware Basin for an undisclosed cash consideration to Admiral Permian Resources, LLC

*Noble Energy, Inc.* — sale of 30,200 net acres in the DJ Basin in Weld County, Colorado to SRC Energy Inc. for \$608 million

*Independent oil and natural gas exploration and production company* – acquisition of Clayton Williams Energy, Inc. for \$2.7 billion in stock and cash

*Independent oil and natural gas exploration and production company* – divestiture of Wattenberg Field assets in the DJ Basin for \$505 million to Synergy Resources Corporation

*Integrated international energy company* — multiple divestitures of its producing assets in the Gulf of Mexico

*Tall City Exploration LLC* — agreement with Moss Creek Resources, LLC to sell its Howard and Borden county assets in Texas for \$803 million

*Private equity-backed seller* — sale of Permian acreage and production to an undisclosed buyer for \$1.24 billion

*Heyco Energy Group, Inc.* — sale of its subsidiary, Harvey E. Yates Company, to Matador Resources Co. in exchange for Matador stock

*Tall City Exploration LLC* — sale of Permian acreage and production to American Energy – Permian Basin, LLC for \$440 million

*Three Rivers Acquisition LLC and Three Rivers Operating Company LLC* – sale of all their Permian Basin oil and gas producing assets to Concho Resources for \$1 billion

**Apache Corporation** — \$3.75 billion divestiture of its Gulf of Mexico Outer Continental Shelf business, including an innovative collateral arrangement to secure the performance by the buyer of \$2 billion of abandonment exposure
