**Competitive Power Ventures** — acquisition of the Canton Mountain, Saddleback Ridge, Spruce Mountain and Beaver Ridge wind projects in Maine from Patriot Renewables

**Invenergy and energyRe** — as project sponsors, in forming a consortium of investors that secured one of six leases in the New York Bight offshore wind auction

**NRG Energy, Inc.** — \$760 million sale to an affiliate of ArcLight Capital Partners, LLC of its ownership interest in eight fossil generating facilities from its East and West regions totaling approximately 4,850 MWs

**Competitive Power Ventures, Inc.** — sale of its majority ownership stake in CPV's largest project to-date, the 1250 MW CPV Three Rivers Energy Center project in Grundy County, Illinois, to affiliates of Osaka Gas USA, Axiom Infrastructure and Harrison Street, which sale closed contemporaneously with the financing of the project, representing over \$1.3 billion in private investment. This deal was awarded numerous recognitions including 2020 "US Power Deal of the Year" by Project Finance International.

**Leading renewable energy developer** — in the sale, development and construction via EPC contracts for three solar plus battery storage projects in the Midwest totaling approximately 1000 MW

**Invenergy LLC** — build transfer sale, subject to state regulatory approvals, of a 250 MW solar energy generating facility to be developed and constructed by Invenergy in Sullivan County, Indiana, to a subsidiary of Northern Indiana Public Service Company
