

Bracewell Represents Southern Natural Gas Company in \$300 Million Senior Notes Offering

HOUSTON – Bracewell LLP represented Southern Natural Gas Company, L.L.C., a 50/50 joint venture between Kinder Morgan, Inc. (NYSE: KMI) and The Southern Company (NYSE: SO), in its Rule 144A and Reg S offering of \$300 million of 5.450% Senior Notes due 2035.

The offering closed July 23, 2025.
