He has tried over 60 court cases, administrative proceedings and arbitrations to successful outcomes and prevailed for clients in many appeals.

Charley is a former chair of the American Bar Association's Derivatives and Futures Law Committee and has long served on the New York City Bar's Committee on Futures and Derivatives Regulation. He also has served multiple terms on the Executive Committee of the Futures Industry Association's Law and Compliance Division. He is a co-author of the treatises *Derivatives Regulation* (Wolter Kluwer), *Broker-Dealer Regulation* (PLI), and *The Securities Enforcement Manual* (ABA, 2007).
